Endeavour for rapid extension and growth of knowledge base economy in the state


To bridge the digital divide which separates the citizen in urban areas from those in rural areas by creating a robust infrastructure and deliver online services to every citizen in the state

To make Bihar an important destination of investment in the IT/ITES/EHM industries and fuel the development of the state




